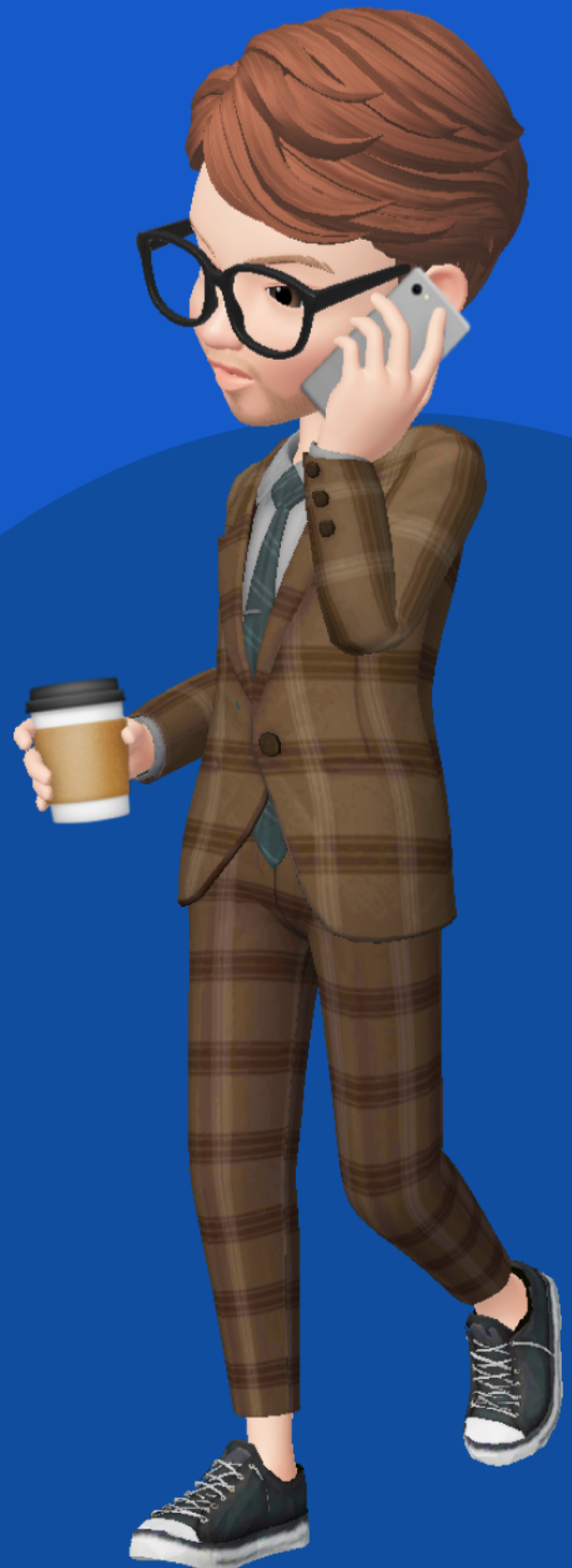

# International banking

**2 ECTS**

**72** academic hours

The discipline starts on the 3 year of study

**With this discipline, you will acquire knowledge on the system of international banking, uncover the role of banking activity and its influence on the development of world's financial credit system. You will learn the principles of how international banks work and what regulations are applicable to this system**

## **You will study**

- basic principles of international banking system
- transactions conducted by international banks
- international banking risks and challenges management
- international banking regulations

## **After this course you will**

- know methods of strategic and economic analysis of world's economic subjects' behaviour
- be able to apply methods of corporate financial management to strategic problems solving, and to develop a comprehensive measures system to forecast the economic risks for a company

# World economics

The discipline starts on the 1 year of study

**With this course you will get acquainted with trends of international economics and international economics subjects' interaction, with the influence of production factors on the real economy**

**3 ECTS**

**108** academic hours

## You will study

- major concepts of the economic development, international economic development indexes and trends
- problems of international corporations' activities
- globalization of economics, its core, trends and future impact
- trade and financial management within a national economics and on a global level
- international trade and financial management organisations

## After this course you will

- know major trends and tendencies of world's financial and currency market and apply them for the analysis of international business
- know the theory of market pricing, as well as peculiarities of its application to pricing systems of different countries
- be able to point out and analyze the economic indexes on a country's and a world's level and use them to forecast the foreign exchange movements

# 3 **Financial and credit risk management**

The discipline starts on the 2 year of study

**The key purpose of mastering the discipline "Financial and credit risk management" is to get basic principles of risk classification and assessment**

**3 ECTS**

**108** academic hours

## **You will study**

- Cross-cultural management: modern tendencies and gaps. The definition of culture in terms of business
- The codependency of national and corporate culture. Western corporate cultures, corporate cultures of Asia, Africa and Middle West
- Leadership style in different cultural backgrounds

## **After this course you will**

- know the major types of credit and financial risks and be able to classify them
- be able to apply different methods of risk situation modeling for decision-making
- be able to conduct an assessment of risk of the bankruptcy of the company

# 4 Information Systems in Management

The discipline starts on the 2 year of study

**The discipline "Information Systems in Management" will help to acquire knowledge of special information systems and technologies that are daily used by professionals in management**

**2 ECTS**

**72** academic hours

## You will study

- Special kinds of IT tools and systems that are used in management
- IT subsystems and components designed for management
- Artificial intelligence, neural networks and intelligent databases and their future in management
- Information security in management

## After this course you will

- be able to use different IT-methods applicable to research and business process or to form an analytical case using professional tools
- be able to use special IT-tools and systems in solving your professional tasks

The discipline starts on the 1 year of study

**The “Investments” course is aimed at training students to make efficient decisions in terms of investments, taking into account macroeconomic trends and conditions for economic development**

**3 ECTS**

**108** academic hours

## You will study

- Investment activity and investment portfolio, management of investment portfolio
- The idea of an investment project, how to make it successful
- Major principles of venture capital investment
- Common risks at long-term investments

## After this course you will

- know the major principles of investment analysis and be able to apply them
- be able to calculate the effectiveness index of an investment project in order to choose the most promising cases
- be able to conduct risk and valuation assessment of portfolio and long-term investment
